This is to bring to notice of all the students and so also the teaching staff that NIT Raipur has arranged for insurance coverage under "UNI Study Care Group Insurance Policy Year/No. 2011/190500/48/11/10/00000266 effective from 29/7/2011 to midnight of 28/7/2012 from United India Insurance Company Limited Raipur . Now student should provide necessary information on the Format prescribed for the purpose. Format can be downloaded from the Institute's website .Two copies of the format should be filled by each student and should be verified by the concerned Head of the Department. One copy of the format shall be retained by the Head and the other copy will be sent to Student Section for record for the purpose of claim under above Insurance Scheme.

**Basic Salient features of this Policy coverage per Student are as Under—**

- 1) Section IA – Compensation in case of Accidental Death, Permanent Total Disablement of the named Parent/ Guardian maximum up to Rs. 3.00 Lacs as per terms and conditions of the Policy.
- 2) Section IB – In the event of Accidental death of named Parent/ Guardian and liability under above section being admitted then Reimbursement of Fees including Hostel, boarding, and other charges as per Institute's rules for entire remaining period of Study after such death of Parent/ Guardian @ Rs. 45000/- per annum shall be made by Insurance Company under this coverage .
- 3) Section II – Compensation maximum up to Rs. 2.00 Lacs for Accidental Death or Total Permanent Disablement of the Student as per terms and conditions of the Policy .
- 4) Section III -- Hospitalisation Benefits – In the event of Student having been admitted for treatment in the Hospital expenses are admissible as per terms and conditions of the policy maximum up to Rs. 25000/- in accordance with the limits prescribed in the table given in the Policy Schedule .
- 5) Section IV – Loss/ Damage to personal baggage of student within the meaning of details mentioned in the Policy Schedule maximum up to Rs.2500/-
