NOTICE

Since less than ten students of VIII semester consented to attend offline classes, the 6th semester students are now invited to attend classes/ practical in offline mode. The classes for 6th semester B. Tech. and B. Arch. will be conducted in hybrid mode (online as well as offline) with effect from 21st March 2022. As per the academic calendar the willing students shall be attending offline practical classes from 01/04 ~ 14/04/2022 after attending offline theory classes up to 31/03/2022. These students of sixth semester UG must note that: -

- 1) They must exercise an option to attend the offline or online classes through a google form, link of which will be shared through students' email id/Whatsapp-group by their respective Head of the Department.
- 2) The students must fill up this form only once and preferably from the same email id which was used by them to access Institute MIS. Please fill up the form carefully as it is not editable.
- 3) Option once exercised will not be allowed to be changed except under extraordinary situation with the approval of the Director, NIT Raipur.
- 4) **The students who have completed both the vaccinations will only be allowed to attend offline classes and to stay in hostel**. The certificate of vaccination must be submitted by the students to the concerned department at the time of reporting.
- 5) Undertakings given in Annexure-I and Annexure-II must be duly signed by the student and his/her parent, respectively and be mandatorily submitted at the time of reporting to respective department.
- 6) The mode of assessment will remain the same as being followed during closure due to COVID, i.e., Digital Examination, Online MCQ and viva-voce will be conducted in online mode. The students attending classes offline will have to appear in these exams/MCQ/viva-voce in person from the departmental Lab/classrooms and failure to do so will be taken as being absent from the concerned exam/MCQ.

- 7) NIT Raipur has limited hostel facility. Depending upon the number of students desirous to avail hostel facilities short listing may have to be carried out. The shortlisting will be purely on the basis of merit (CPI). Please note that only the regular students having no backlog in previous semester(s) are eligible for hostel allotment.
- 8) Hostel fee for this semester which is <u>Rs. 15,500/-</u> (inclusive of mess advance Rs.9500/-, Caution money- Rs.1000/-, Hostel Management and Maintenance fee- Rs.1500/-, Room rent, water and electricity charges Rs.3500/-) must be paid within the duration specified in the point No. 9 below else the admission to the hostel will not be made. Further, the caution money is refundable and the mess advanced shall be deducted as per actual expenditure made. For details of the hostel fee please contact Chief Warden Boys' (chiefwarden.boys@nitrr.ac.in) or Chief Warden Girls' (chiefwarden.girls@nitrr.ac.in).
- 9) Filling up of the consent is mandatory for all the students of abovementioned semester/program. The last date of filling the option through google form is 12.03.2022 up to 05:30 PM. Publication of Hostel allotment list will be made by 14.03.2022 by 8:00 PM. The students who have been allotted the hostel must pay the above-mentioned hostel fee from 15.03.2022 to 20.03.2022 up to 5:30 PM.
- 10) The students who have paid the hostel fee must contact authorities of the allotted hostel with hardcopy of receipt of hostel fee payment and the certificate of double vaccination at the time of reporting. If a student fails to produce any one of these documents, then he/she will not be allowed to stay in the hostel.
- 11) The hostel allotment shall be for this semester only. The tenant will have to vacate the accommodation mandatorily at the end of semester, i.e., latest by May 20, 2022.
- 12) The Institute reserves the right to get the hostel vacated and switch back to online classes whenever so required due to the pandemic situation.
