(iii) Criteria for allotment: Merit, category and distance of home town from Raipur.
Location of NIT Raipur	The institute is located on GE road in the city of Raipur, the capital of Chhattisgarh at a distance of about 5 km from the Raipur railway station and about 20 km from the Raipur airport. The city is well connected from Mumbai, New Delhi, Chennai, Bhubaneswar, Vizag, Nagpur and Kolkata through air. Railway station is on Mumbai-Howrah railway route in South East Central Railway (SECR).
How to reach NIT Raipur Campus	From Raipur Airport private auto / taxis are available directly to NIT Raipur Campus with fare approximately Rs. 600/-. From Raipur Railway Station, City Buses toward Tatibandh / Mahoba Bazar / Amanaka are available, which stop at NIT Raipur Main Gate. Or number of Prepaid Auto / taxis are available with fare approximately Rs. 100-150. Or Public Auto can also be availed from Raipur Railway Station to Ghari Chowk and then from Ghari Chowk to NIT Raipur. From Raipur Bus Stand (Pandri) number of private Auto / taxis are available with fare approximately Rs. 100-150. Or Public Auto's can also be availed from Raipur Bus Stand to Ghari Chowk and then from Ghari Chowk to NIT Raipur.
