#### NOTE

- Documents mentioned under points (ii), (iii), (xiv), (xv) (xvi) (xvii) and (xviii) will be retained by the institute and remaining documents will be returned to the candidate after verification.
- If the original certificates are not in Hindi/ English, **duly certified Hindi/ English version/ translation of such certificates have to mandatory brought, failing which the certificate may not allowed.**
- Candidates are instructed to keep sufficient number of Photocopies of the original documents submitted.**

#### Hostel accommodation

- Only limited no. of seats for boys & girls are available in the hostels of the Institute which are allotted strictly on the basis of merit, category and distance of home town from Raipur.
- The candidate are advice to make alternative arrangement In case, they are not able to get the hostel accommodation.
- After institute admission, interested students must have to contact hostel admission counter at the institute. #### Location of NIT Raipur

The institute is located on GE road in the city of Raipur, the capital of Chhattisgarh at a distance of about 5 km from the Raipur railway station and about 20 km from the Raipur airport. The city is well connected from Mumbai, New Delhi, Chennai, Bhubaneshwar, Vizag, Nagpur and Kolkata through air. Railway station is on Mumbai-Howrah railway route in South East Central Railway (SECR).

#### How to reach NIT Raipur Campus

From **Raipur Airport** private auto / taxi's are available directly to NIT Raipur Campus with fare approximately Rs. 600/-.

From **Raipur Railway Station**, City Buses toward Tatibandh / Mahoba Bazar / Amanaka are available, which stop at NIT Raipur Main Gate. Or number of Prepaid Auto / taxi's are available with fare approximately Rs. 100-150. Or Public Auto can also be availed from Raipur Railway Station to Ghari Chowk and then from Ghari Chowk to NIT Raipur.

From **Raipur Bus Stand (Pandri)** number of private Auto / taxi's are available with fare approximately Rs. 100-150. Or Public Auto's can also be availed from Raipur Bus Stand to Ghari Chowk and then from Ghari Chowk to NIT Raipur.

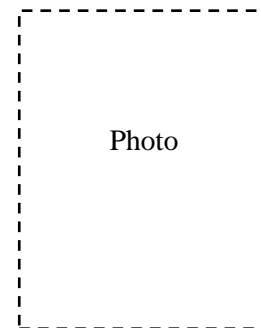
