The candidates who have accepted seats (First to sixth rounds) in JoSAA-2021 and **provisionally allotted** in B.Tech./B.Arch. programs of National Institute of Technology Raipur for the academic year 2021-2022 are **compulsorily** required to read the instructions and do the formalities as mentioned by JoSAA/CSAB-2021 (link for instructions: <https://josaa.nic.in/webinfo/File/ViewFile?FileId=18&LangId=P>).

With the instruction of JoSAA/CSAB – 2021, the **PROVISIONAL** admission process of NIT Raipur will be in **ONLINE** mode ONLY and can be processed with following **TWO** Steps:

1. All the candidates who have accepted a seat in JoSAA-2021 (First to sixth rounds) **need to perform the STEP-1 of JoSAA/CSAB-2021 Instructions and pay the partial admission fee of Rs. 40000/- [GEN/GEN-EWS/OBC-NCL] and Rs. 20000/- [SC/ST/all PwD] through JOSAA PORTAL ONLY TO SECURE THE ADMISSION from 20<sup>th</sup> -24<sup>th</sup> November 2021 [Candidates who do not pay PARTIAL ADMISSION FEE during 20<sup>th</sup> -24<sup>th</sup> November 2021 will be treated as candidates who are not interested in taking admission in their allotted institute (NIT Raipur) HENCE, their allotted seat will be CANCELLED].**
2. Such candidates who have done the above-mentioned formalities (STEP-1,) are advised to further report **ONLINE** to the NIT Raipur for admission along with the documents listed here under and as per the schedule with the link provided below:

**The OBC-NCL certificate should clearly mention that the candidate belongs to non-creamy layer.**

5. **Transfer certificate/ School leaving certificate/college leaving certificate** as applicable and **Migration certificate** (from board/university, as applicable) and **Character / Conduct certificate** (if the conduct is mentioned in TC, then not required) in **SINGLE FILE or PDF**.

7. Aadhar Card (compulsorily) and / or any Govt. issued **identity proof** card.
