

MEMORANDUM OF UNDERSTANDING

This Memorandum of Understanding (MoU) is entered on the 25thday of April, 2018 at UdyogBhawan, Raipurin Chhattisgarh.

National Institute of Technology, Raipur,

and

Department of Commerce and Industry, Chhattisgarh acting on behalf of Chhattisgarh State, (hereinafter referred to as "DOI" which expression wherever the context means and requires will include its successors in interest and permitted assigns and represented by its Director of Industries, Chhattisgarh)

National Institute of Technology, Raipur and Directorate of Industries wishes to enter into a Memorandum of Understanding (MoU). The MoU will furnish the following objective:

- 1.1 The Chhattisgarh Government desires to provide boost to entrepreneurial talent to skilled youth.
- 1.2 The Government of Chhattisgarh has identified the need for creating an enabling environment for fostering the Startup activities in the State.

Term of Partnership

- 1.3 The partnership between National Institute of Technology, Raipur and DOI shall be valid for a minimum period of three (3) years. During the term of such partnership, the following shall be the obligations and the deliverables of National Institute of Technology, Raipur and the DOI;
- 1.4 Obligations of DOI.
 - 1.4.1 DOI will conduct start up outreach and sensitization boot camps for students and faculties of National Institute of Technology, Raipur.
 - 1.4.2 DOI will provide pool of Mentors, Speakers and Entrepreneurs to National Institute of Technology, Raipur for conducting events, workshops and mentoring sessions.
 - 1.4.3 DOI will provide Industry Interaction for student entrepreneurs.

- 1.5 Obligations of National Institute of Technology, Raipur
 - 1.5.1 National Institute of Technology, Raipurwill provide infrastructure for conducting events, workshop and mentoring sessions.
 - 1.5.2 National Institute of Technology, Raipurwill provide support for DOI's initiatives to develop the startup ecosystem in the state.
 - 1.5.3 National Institute of Technology, Raipur will provide pool of mentors/experts from its faculty to DOI, who can guide and help early stage startups.
