

## **MEMORANDUM OF UNDERSTANDING**

This Memorandum of Understanding (MoU) is entered on the 27th day of April, 2018 at Raipur in Chhattisgarh.

AIC@36Inc, a government society registered under the Societies Act 1860 and having its registered office at State Data Centre, Civil Lines, Raipur - 492001 and acting on behalf of Chhattisgarh State, (hereinafter referred to as "AIC@36Inc" which expression wherever the context means and requires will include its successors in interest and permitted assigns and represented by its CEO of the ONE PART;

National Institute of Technology, Raipur and AIC@36Inc wishes to enter into a Memorandum of Understanding (MoU). The MoU will furnish the following objective:

1.1 AIC@36Inc is the nodal agency of Government of Chhattisgarh for entrepreneurship development in Chhattisgarh. AIC@36Inc has set up Core Incubator-cum-Accelerator in Raipur. AIC@36Inc is working on Hub and Spoke model to spread its operation across state of Chhattisgarh. AIC@36Inc is developing Incubator across Chhattisgarh to reach local entrepreneurs at different region of Chhattisgarh.

## **Term of Partnership**

- 1.2 The partnership between National Institute of Technology, Raipur and AIC@36Inc shall be valid for a minimum period of one (1) year. This MoU can be modified by mutual agreement or terminated at either party's discretion. During the term of such partnership, the following shall be the obligations and the deliverables of National Institute of Technology, Raipur and the AIC@36Inc;
- 1.3 Obligations of AIC@36Inc.

- 1.3.1 AIC@36Inc will provide training and development program for employees of incubator at National Institute of Technology, Raipur.
- 1.3.2 AIC@36Inc will provide pool of Mentors, Speakers and Entrepreneurs to National Institute of Technology, Raipur for conducting events, workshops and mentoring sessions.
- 1.3.3 AIC@36Inc will provide incubation to selected promising start-ups of incubation centre at National Institute of Technology, Raipur. Co-working Space, if available, will be provided to these startups. Start-Ups will be entitled for the benefits as per the prevailing norms of Startup India Programm, Govt. of India.
- 1.3.4 AIC@36Inc will provide access to its program partners to National Institute of Technology, Raipur and vise-versa
- 1.3.5 AIC@36Inc will ensure Industry Interaction for entrepreneurs.
- 1.3.6 AIC@36Inc will provide following benefits to each startup incubated at Incubation Centre (Corresponding monetary value of such service is also mentioned) :
