To implement above decision –

- (i) Institute will arrange special exam in October 2016 only for above students and only in required subjects/semester. Time table of this exam will be separately communicated by examination cell. **If a student remains absent in this special exam then he/she will lose his chance.**
- (ii) To help the students to pass their backlog papers, department may arrange special guidance classes. For this, students have to approach concern HOD and request for the guidance classes.
- (iii) Students who are permitted to attend the classes provisionally in Autumn 2016 need not to pay any fee at present. However they have to pay the fee at the time of regularizing their admission.

- (iv) First Exam (CT – I) of such provisionally admitted students will be arranged separately on a convenient date by the department after regularization of their admission. They will have to appear in Second Exam (CT – II) alongwith regular students of the class.

The above decisions are made as a special case and these should not be quoted as precedence in future.

All existing students of NIT Raipur are warned to be careful about the implications of implementation of maximum time limit clause of completing the course. This is advised in the interest of the students and to avoid grievances in this matter.
