4. The candidates belonging to reserved categories must bring their recent original caste certificate in the prescribed format for employment in Central Government Organizations.
5. The candidates belonging to PWD status must bring disability certificate issued by competent medical authorities as applicable for employment in Central Government Organizations. Final selection will be made on the basis of recommendations of medical board to be appointed for examining the physical disability.

The candidates who are already employed in Government (Central/ State), Semi-Government, Government Aided Organizations/Institutions, Government Autonomous Bodies/Institutions must bring original copy of 'No Objection Certificate' issued by Competent Authority of their Organization. No extension will be given to submit this document.
7. No Travelling Allowances (TA) and DA shall be payable to the candidates for appearing for the document verification.
8. Candidates should come prepared for over-night stay in case the document verification gets prolonged. Candidates will have to make arrangements for stay (if necessary) on their own.
