To consider and permit NIT Raipur to sign PPA with M/s. Jyotikiran Energy Mumbai Pv Ltd. in place of M/s. Sunsource Energy Pvt. Ltd. for installation of Grid Connected Sola Power Plant (490 KwP) at NIT Raipur with same terms and conditions.
The Board in its 47 <sup>th</sup> meeting held on 14.08.2020 had approved the recommendation of 42 <sup>nd</sup> meeting of Finance Committee for installation of Grid Connected Solar Power Plant of 490 kWp capacity in RESCO mode at the existing campus of NIT Raipur, and had accorded the approval for signing of the Power Purchase Agreement(PPA)with M/s. SunSource Energy Pvt. Ltd. Noida.
The Board was apprised of the email dated 28.09.2020 received from M/s. SunSource Energy Pvt. Ltd. Noida with attached letter dated 19.03.2020 of Solar Energy Corporation of India (SECI) to M/s. SunSource Energy Pvt. Ltd. Noida according to which M/s. Jyotikiran Energy Mumbai Private Limited, a 100% subsidiary of M/s. SunSource Energy Pvt. Ltd. Noida, is authorized by the SECI for execution of its entire allocated capacity in Zone-3 (which includes Chhattisgarh state).
Considering the approval accorded by the Board in its 47 <sup>th</sup> meeting held on 14.08.2020, the Board further considered and approved signing of the PPA with M/s. Jyotikiran Energy Mumbai Private Limited for installation of Grid Connected Solar Power Plant of 490 kWp capacity in RESCO mode at the existing campus of NIT Raipun with the same terms and conditions. It was directed to confirm that Performance Bank Guarantee(PBG) in the name of M/s. Jyotikiran Energy Mumbai Private Limited has been submitted to Solar Energy Corporation of India (SECI) and to ensure fulfillment of all other norms by M/s. Jyotikiran Energy Mumbai Private Limited at the time o signing of the PPA by the institute.
