The 58th Special Meeting of the Board of Governors of NIT Raipur was held on 02.06.2023 from 12:30 Hrs. onwards at Mini Conference Hall of NIT Raipur.

At the outset, the Secretary, BoG informed that there exists a vacancy at the level of Chairperson, BoG as the same is yet to be appointed by the Hon'ble Visitor. Therefore, as per Statute No. 17(15) read with Section 16 of NITSER Act, 2012; the Director of the Institute can chair the meeting. Accordingly, Dr. A. B Soni, Director I/C, NIT Raipur chaired the meeting of the Board of Governors of NIT Raipur. Mrs. Anita Verma did not attend the meeting and she was granted Leave of absence. Joint Secretary & Financial Advisor could not attend the meeting. However, the comments were received through email from Joint Secretary & F A which was laid by the Secretary before the Board.

The Chairperson welcomed all the members present in the meeting. After ascertaining the quorum, the Chairperson permitted Secretary, BoG, NIT Raipur to present the agenda items. The point-wise deliberations of the meeting are as under:

	employees who were working in the Institute on ad-hoc /temporary/contractual/ outsourc
	basis as on the date of the MHRDs OM i.e.20.02.2019 and are continuing on the day of
	advertisement subject to the condition that they fulfil all other conditions mentioned in th
	Recruitment Rules for the applied post, as per the Ministry of HRD letter No. F.35-5/2018
	TS.111, dated 20.02.2019. It was also resolved that the age relaxation will be equal to the
	length of the service that the above-stated employees have put in NIT, Raipur without
	considering the break period and will be over and above the maximum age prescribed for
	that the post, after considering the statutory age-relaxations.
