Resolution: The minutes of 21st meeting of BWC held on 13.10.2016 was confirmed with following amendment in *Agenda No. 21.2* in light of the minutes of 29th meeting of Finance Committee held on 11.11.2016 wherein w.r.t. its *Agenda Point No. 29.3: To consider and approve the Revised Estimate submitted by EPIL for renovation of Hostel A,B,D,E and F at the existing campus of NIT Raipur*, the Finance Committee in its 29th meeting held on 11.11.2016 deferred the proposal and directed to ask EPIL to complete the work as per the Clause No. 08 (1) of the Contract Agreement signed with EPIL.

Supplymentary Agenda: 22.1 (i) Evacuation of H-Type abandoned quarters occupied by C.G. Govt. Employees.

Discussion It was informed that at present two abandoned quarters have been occupied by C.G Govt. Employee. Notices for evacuation of such quarters have been also issued to them, however till date they have not vacated the quarters.

Resolution The committee resolved to make efforts to evacuate the illegal occupied Quarters immediately. BWC advised CPWD to demolish the vacant H-Type quarters in order to start work of construction of G+6 Quarters.
