\*\* Gen/Gen-EWS/OBC candidate claiming/ availing the remission of tuition fee must have to produce the family income certificate issued from **competent authority** (e.g. DM/DC/SDM/SDO /Tahsildar) for the latest financial year. Income certificate must be issued on or after **01/04/2021**.

Without annual income certificate, student will not be given remission of tuition fee.

The OBC-NCL / GEN-EWS certificate must be issued on or after April 1, 2021. The OBC-NCL certificate should clearly mention that the candidate belongs to non-creamy layer.
