- After successful verification at the Institute level, concerned candidate will receive a payment link in his/her registered email Id.
- After successful payment and confirmation at the institute level a provisional admission slip will be available on the candidates' login Id.

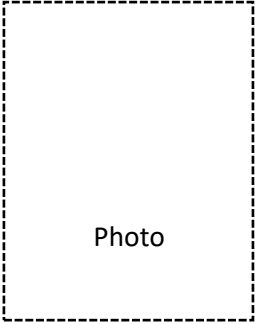
