

# Information sheet for B.Tech. / B.Arch. Admission 2024-25 through DASA – 2024

Venue: Main Building, Second Floor, Room No. D4

As per the instruction received from DASA 2024 dated 22/07/2024, the allotted candidates of DASA-2024 need to undergo online reporting to their allotted institute **during 25-27 July 2024 and physical reporting for the admission during 08-14 Aug. 2024.** For Online reporting candidates are required to send the documents (listed in Table-1) in a **single pdf file** to **ugadmission@nitrr.ac.in**.

After online verification, candidates are required to report physically for admission (with all original documents listed in Table-1) during 08-14th Aug 2024 at National Institute of Technology Raipur.

- (xviii) Soft copy of formal color (white background) passport size photograph (30 to 40 kb) & soft copy of signature in size (10 to 20 kb).

- 1. If the original certificates are not in Hindi/English, duly certified Hindi/English version/translation of such certificates will be required.
- 2. One set of self-attested copies of all the documents listed above.
- 3. The original documents listed in S. No: (i), (ii), (xii), (xiii), (xiv), (xv), (xvi) and (xvii) will retained by the institute at the time of physical reporting however theother original documents will be returned to the candidate after verification.
- 4. Candidates are instructed to keep sufficient number of Photostat copies of the original documents submitted.
