10	Original Degree / Provisional certificate, if qualifying degree is completed. In these cases, all exams should have been completed by August 15, 2025. A certificate from the head of the current institute (format given on the CCMT website) to that effect should be submitted during reporting.

- Documents mentioned under points 2,3,4,15,16,17,18,19&21 will be retained by the institute and other documents will be returned to the candidate after verification.
- If the original certificates are not in Hindi/ English, duly certified Hindi/ English version/ translation of such certificates have to be mandatory brought, failing which the certificate may not allowed.
- Candidates are instructed to keep sufficient number of Photocopies of the original documents submitted.

- After successful verification at the Institute level, concerned candidate will receive a payment link in his/her registered email Id.
- After successful payment and confirmation at the institute level a provisional admission slip will be available on the candidate login Id.
