**Applicants must report at NIT Raipur for spot round seat allocation to PG programmes on 20.08.2025 between 10.00 am to 12.30 Noon.**

**Please read this document carefully before applying.**

Applications are invited for Institute level **Spot Round** of admissions in MTech., MSc. And MCA programs of the Institute against the seats remaining vacant after CCMT, CCMN and NIMCET 2025 admissions, respectively. **Candidates who have already taken admission in any other Institute through CCMT-2025/CCMN-2025/NIMCET-2025 NEED NOT APPLY** for these admissions. Also, candidates desirous of applying are advised to check the availability (vacancy) of seats in their respective categories and desired specialization before applying.

**How to apply and Eligibility: -**

The candidates desirous of applying for spot round of admissions should register their applications online by submitting the form at the link given below and **should report physically on 20.08.2025 with all relevant documents of qualification, caste etc., proof of application fee payment and a demand draft of INR 9000/- (as Seat Participation Fee).** The Spot Round application processing fee is Rs. 1500/- for OP, OBC and OP-EWS and Rs.750/- for SC, ST, Diyang applicants. Please note that the application fee is non-refundable. The application is available at:

*Last date of submitting it is 19.08.2025. After filling in the forms, all applicants must report physically at NIT Raipur on 20.08.2025 by 10.00 am at IEM Lab of the Institute. Mere submission of the application form does not entitle an applicant to claim a seat in the programme.*

*Registration on the spot is also permitted on 20.08.2025, however, such applicants have to come prepared with all the documents, application fee and seat participation fee on spot.*

**A. For M. Tech. programs:**

The eligibility for admission shall be the same as those in CCMT. The applicants are, therefore, to go through the **CCMT 2025 information carefully before applying.** The category certificate formats, and list of qualifying degrees are available at CCMT 2025 website. Applicants with a valid GATE-score shall be eligible for institute scholarship, if selected.

In case, enough candidates with valid GATE-score are not available against vacant seat(s) in a specialization, then applications from non-GATE candidates can also be considered. For such candidates the other eligibility criteria, except GATE-score, shall remain the same as those of CCMT 2025. Such candidates shall have to appear in an exam/Interview in the respective department on the same day. **Candidates who do not have a valid GATE score, if selected for admission, shall not be eligible for the scholarship from the Institute.**

**B. For M. Sc. programs:**

The category certificate formats, and list of qualifying degrees is available on the CCMN 2025 website. The applicant must have a valid JAM score. The eligibility for admission shall be the same as that in CCMN (for M.Sc.) 2025. The applicants must read the CCMN 2025 information brochure carefully before applying. **Institute scholarship is not offered in M.Sc. programme.**

**C. For MCA programme:**

The applicant must have a valid NIMCET AIR. The eligibility for admission shall be the same as those in NIMCET 2025. The applicants must read the NIMCET 2025 information brochure carefully before applying. Institute scholarships are not offered in the MCA programme. The category certificate formats could be downloaded from the NIMCET 2025 website.

**Important Instructions:**

The **tentative** available vacancy after CCMT, CCMN & NIMCET rounds of admission at NIT Raipur in M. Tech., M.Sc. and MCA programmes respectively is provided in this document under the section “Information sheet”. In case no PH (PWD) candidates apply against the available PH vacancies through CCMT/CCMN/NIMCET, then these seats shall first be converted to respective categories. Similarly, if no application is received against a GEN-EWS seat, then the institute reserves the right to convert it to the Unreserved category. After such conversions, the sliding of the candidates already admitted at NIT Raipur shall be carried out first as per their preference and eligibility and then the remaining vacancies shall be filled by ‘Spot-Round’ applications.

For M. Tech. programmes, if the applicant is eligible and interested in applying for admission in more than one specialization as per her/his eligibility defined by the business rules of CCMT, she/he may indicate her/his order of preference in the application form. There is no need to fill separate form for each specialization.

Please note that Transfer, Migration and Character certificate, in original, from the Head of Institution studied prior to this admission must be produced at the time of Interview or admission, if selected.

The Institute reserves the right to restrict the number of applicants called for admission/for taking a chance for the admission, if the number of applications in a program/discipline is very large.

**Note:**

- A. An applicant who is called for admission or for taking a chance for admission must bring a Demand Draft of INR 9000/- as Seat Participation Fee, in favor of the Director, NIT Raipur payable at SBI NIT Raipur branch (IFSC code: SBIN0002852). In case an applicant is not offered admission then the demand draft shall be returned to him/her. If selected, and the candidate joins the programme, then the amount shall be adjusted in the first semester fee, as applicable. If selected and the candidate does not join the programme, then the amount shall be forfeited and shall not be returned to the candidate.
- B. Applicants must note that they must report to the Institute on 20.08.2025 at 10.00 am to 12.30 Noon mandatorily. Candidates reporting after 12.30 Noon on 20.08.2025 may not be considered for admission on the advertised seat. The decision of NIT Raipur shall be final in this regard.
- C. Institute shall update relevant information pertaining to admission (through this Spot Round) and subsequent activities from time-to-time on the Institute Website. The candidates are advised to visit the Institute website regularly for subsequent updates, if any.
- D. Institute reserves the right to refuse admission to any candidate, or cancel the whole admission process, without assigning any reason.
- E. In case of any ambiguity, typographical error or mistake, the decision of Chairman, Senate, NITRR shall be final.
- F. All disputes related to admission shall be subjected to Raipur Jurisdiction only.
- G. The applicant shall not be reimbursed any fare for travelling and will have to make her/his own arrangement for stay, if required.

### Spot Round Admissions 2025-26 for M. Tech./M.Sc. Programme

NIT Raipur is going to conduct spot round for vacant seats in M. Tech./M.Sc./MCA programme. **Kindly note that those who have been already admitted to other institutes through CCMT-2025/CCMN-2025/NIMCET-2025 are not eligible to apply for the Institute Spot Round of admissions at NIT Raipur.**

<b>Joining the Program</b>	After a seat is allotted in Spot Round, the candidate, to whom the seat is allotted, shall pay remaining semester fees, if any, submit the required documents, as per the instructions delivered, with undertaking and confirming her/his admission. After this, she/he will start attending the ongoing classes of their respective programmes.
<b>Mode of Payment of Spot Round application fee</b>	The non-refundable Spot Round application fee is Rs.1500/- for OP, OBC and OP-EWS and Rs.750/- for SC, ST, Divyang applicants. In case the payment is not received, the application will not be considered. The applicant must also come prepared to pay the seat participation fee of INR 9000/- fee in form of a Demand Draft drawn in the favor of Director, NIT Raipur payable at SBI NIT Raipur branch (IFSC code: SBIN0002852).

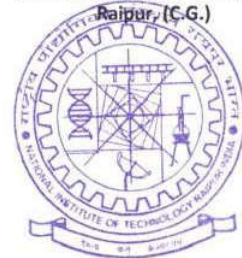

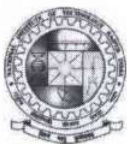

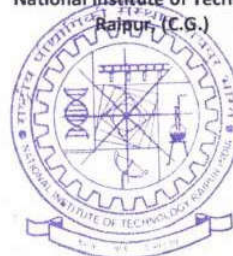
