## Information sheet for B. Tech./B.Arch.Admission2025-26 through JoSAA/CSAB – 2025

The admission procedure for the candidates who had provisionally **allotted a seat** in B. Tech./B. Arch. Programs of National Institute of Technology Raipur for the academic year 2025-2026 through the counselling processes given below shall be as shown from the next paragraph:

- I. The candidates who got allotted and accepted seat (First to sixth rounds) in JoSAA-2025 and paid the Partial Admission Fee (PAF) online from their JoSAA portal (23<sup>rd</sup> July 27<sup>th</sup> July 2025)
- II. The candidates who have participated in **CSAB-2025** (First to third rounds) and allotted the seat and paid all the required fee as mentioned in CSAB/JoSAA –2025 procedure.

Important Note

AS PER THE RESOLUTION OF 52<sup>nd</sup> SENATE, BRANCH SLIDING PROCESS OF B. TECH. PROGRAMS HAS BEEN WITHDRAWN. THERE WILL BE NO PROVISION OF BRANCH CHANGE AFTER SECOND SEMESTER FOR THE ADMISSION BATCH OF 2025-26 AND ONWARD.

## Procedure for Reporting in Person at NIT Raipur

1. The candidates who have been finally allotted to NIT Raipur need **to access the institute** MIS/login through ONLINE mode before physically reporting as per the scheduled mentioned in <u>Table-1</u> to NIT Raipur for admission. The link for the same is given below (the link has also been sent to your registered email id as per JoSAA/CSAB records), which will be activated onward 08 AM, 20<sup>th</sup> August 2025 (subject to the allotment of CSAB Special round 3):

The candidates need to login in the institute interface (MIS) for provisional admission through their **JEE(Main) Application Number, Date of Birth, and other credentials.** Please fill in all the editable fields as provided at your login, with correct information and upload your photo and signature. An email will be sent to your registered email id on successful completion of the above entry on MIS. **You need to show this email at the counter (Help Desk and Registration Counter) at the time of Physical reporting to the institute.** In case of any difficulty in MIS related issues, the candidate can write email to <u>ugadmission@nitrr.ac.in.</u>

**Kindly note that merely entering the details after logging-in shall not make you eligible to take admission at NITRR unless you have not been allotted NITRR by JoSAA/CSAB - 2025,** During verification by officials if it is observed that you have not done the formalities as per the instructions, your entered data will be removed from the institute database, and you will be treated as unadmitted/cancelled candidate.

Note: The above fee structure is semester-wise. Since, the receivable amount of the allotted candidates from JoSAA/CSAB-2025 is less than the first semester fee, candidates must pay the remaining academic fee during admission ( $20^{th} - 25^{th}$  August 2025). The payable amount at the time of physical reporting is:

- Gen/OBC-NCL/EWS (Income > ₹5 lakh): ₹37,800
- Gen/OBC-NCL/EWS (Income ₹1–5 lakh): No fee
- Gen/OBC-NCL/EWS (Income < ₹1 lakh): No fee
- SC/ST/PwD : **₹15,300**

The payment (as applicable) can be made through various mode such as online through **net banking, credit/debit card, UPI,** etc.

The students need to pay the second semester fee (as applicable) during registration of II Semester in Jan 2026 (Spring - 2025).

Tuition Fee Remission: GEN/GEN-EWS/OBC-NCL candidate claiming/ availing the remission of tuition fee must have to produce the family income certificate issued from competent authority (e.g.DM /DC /SDM /SDO /Tahsildar) for the latest financial year. The income certificate must be issued on or after 01/04/2025.

Without a valid income certificate, students will not be given remission of tuition fees.

- 4. Documents Required: The eligibility and other criteria will be as per the JoSAA/CSAB-2025 Business rule. The following essential documents mentioned below are required to be produced in original at the time of Physical reporting / admission (Please bring self-attested one set of photocopies of all documents listed below and arrange the same in order as follows.):
  - Duly filled admission form (Given in Annexure I, page: 07 of this Bulletin) along with 2 color passport size photographs.
  - ii. Document Verification cum Seat Acceptance Letter received online from JoSAA/CSAB portal.
  - iii. Print out of current seat allotment.
  - iv. Score Card of JEE(MAIN)2025.
  - v. Class X (High School) Mark sheet/Board Certificate as proof of name & date of birth.
  - vi. Pass Certificate and Marks sheet of qualifying examination (class XII).
  - vii. Certificate of OBC-NCL/GEN-EWS/SC/ST category (as applicable), issued by the competent authority in the prescribed format (can be downloaded from <a href="http://josaa.nic.in">http://josaa.nic.in</a>) The OBC-NCL/GEN-EWS certificate must be issued on or after April1, 2025.

The OBC-NCL certificate must clearly mention that the candidate belongs to the non-

creamy layer.

The candidates submitting the caste certificate (SC/ST/OBC-NCL) need to verify their correct caste name in the state-wise central list of SC/ST/OBC at the respective Government of India portals.

- viii. Certificate for Persons with Disabilities (PwD) in the prescribed format/UDID Card, if applicable (format **PwD Certificate Proforma** can be downloaded from <u>http://josaa.nic.in</u>).
- ix. Medical Certificate (in specified Format available on JoSAA/CSAB –2025 format)
- x. Transfer certificate/School leaving certificate/college leaving certificate as applicable.
- xi. Migration certificate (from board/university, as applicable).
- xii. Character/Conduct certificate (if the conduct is mentioned in TC, then not required).
- **xiii.** Aadhar Card (<u>compulsorily</u>) and/or any Govt. issued **identity proof** cards.
- xiv. Income certificate (if applicable) issued from competent authority (e.g. DM/DC/SDM/ SDO/Tahsildar) for the GEN / OBC-NCL / GEN-EWS candidate claiming for the remission of tuition fees for the latest financial year. <u>The income certificate must be issued on</u> <u>or after 01/04/2025</u>.
- xv. Soft copy of formal color (white background) passport size photograph (50 to 100 kb) & soft copy of signature in size (20 to 50 kb). [If already uploaded in institute MIS login, then not required]
- xvi. Cancelled Cheque/ First Page of Bank passbook (bank account should be in the name of Students /Parents) [This is required for the refund of excess fees, if any].
- **xvii.** Affidavit/undertaking (Annexure-IIA/IIB and III given at Page 8-10 of this Bulletin, Annexure IIA and III must be Notarized by Oath Commissioner)
- **xviii. Other Documents (if applicable)** such as additional affidavit /undertaking, Passport, Proof of place of examination Center for Open School candidates, etc.

Note:

- 1. Original documents mentioned under points (ix), (x), (xi), (xii) and (xvii) will be retained by the institute and remaining documents will be returned to the candidate after verification.
- 2. One set of self-attested copies of all the documents listed above.
- 3. If the original certificates are not in Hindi/English, duly certified Hindi/English version/ translation of such certificates will be required.
- 4. Candidates are instructed to keep sufficient number of Photostat copies of the original documents submitted.
- **5. Flow of the process** during physical reporting as per the respective dates mentioned in Table 1:



#### 6. Hostel Accommodation:

- a. **Only a limited number of seats for boys & girls are available** in the hostels of the Institute which are allotted strictly based on merit and category.
- b. The candidates are advised to make alternative arrangements; in case they cannot get hostel accommodation.
- c. After institute admission, interested students must have to contact hostel admission counter at the institute. Details of hostel admission fee are given at in the institute website(<u>http://www.nitrr.ac.in/hostel.php</u>). *Hostel fee must be deposited only after hostel seats are allotted to a student.*
