	The committee, based upon its findings, shall then recommend for/against opening of the proposed programmes to Senate for further necessary and required action. In view of the proposals received, the committee shall review and recommend the commencement year of the programme, if deemed fit to start the same.  The committee shall also examine the distribution of seats in the proposals of the new programmes and the prospect of reducing the seats from the existing programmes of the department. It was further decided that the declared seats under sponsored category in ongoing PG programmes is having an adverse effect in term of declared intake that goes vacant due to the non-availability of sponsored candidates. Hence it was resolved to advertise the sponsored seats institute-wide instead of programme-specific vacancies. These seats will be over and above the regular intake in such PG programmes. It was resolved that the institute-wide sponsored seats to be advertised shall not exceed 10% of the total sanctioned intake.  For the Industry Sponsored Seats (DRDO sponsored): Senate, in-principle approved to facilitate accommodation for the industry sponsored personnel at Vindhyanchal and Satpura apartment. It was resolved to utilize 6 number of quarters at the apartment for the above purpose as family accommodation.  The above designated committee shall work out the modalities of allotment of
	accommodation to DRDO sponsored M. Tech. students.
