Circular

Online fee payment cum admission to 3rd 5th 7th BTech/BArch, 9th BArch and 3rd, 5th PG will commence from 27/08/2020. The regular students of need not come to the Institute but must pay the applicable semester fee as shown in the appropriate table given in the Annexure-I (for autumn semester 2020) online through the Institute website (payment gateway). Fee payment activity for the regular students of NIT Scheme i.e. 5th, 7th, 9th Semesters will start from 31/8/2020 from 11:00AM and for the regular students of 3rd CBCS scheme from 07/09/2020. The last date of payment of fee is 13/09/2020 by 11:59 PM. Fee with applicable late fee will be payable up to 18/09/2020 by 11:59 PM. In the meantime, the students must fill up the attached admission form, etc, as directed in the given Instructions (on the next page) and send it to their HoDs.

The UG students desirous of availing the waiver in full or part of the tuition fee should send the latest income certificate to their HoD as per the instructions on the next page, if the certificate is in order then only they will be allowed to pay the concessional fee (with waiver). The students need to make sure of their eligibility as per the ordinance applicable to them for admission to the desired semester. The online classes will continue in the meantime.

In the prevailing circumstances of COVID 19 pandemic, the Senate of the Institute has approved to allow for an attendance relaxation of One year to the students who intend to opt out of the registration and subsequent academic activities. Under such circumstances, they will not be registering for their regular semesters and hence will not be allowed to participate in the academic activities planned by the institute (both online and contact-mode). However, such cases will not to be treated under the 'Withdrawal' rule of all the Ordinances and the period of absence will not be counted in determining the eligibility of maximum duration for the programme undertaken by such students. Also, this break will be permissible for a full one year and a part thereof will not be allowed.

Students desirous of availing this year-long break will mandatorily have to exercise an option on/before 18/09/2020 by 03:00 PM. The option form is available herewith as Annexure -II. The desirous students must fill this option form sign it, get it countersigned by their parent and send a scanned copy to their HoD. Once the option of availing break is exercised by a student, it will not be rolled back. Such students are not required to pay the semester fee and their regular admission in due semester will be allowed in July,2021.

Instruction for students

- The scanned copies of the duly filled and signed prescribed application form(Annexure-III) along with self-attested copies of valid income certificate(Only for UG ,If applicable), converted in a single PDF file, should be sent through e-mail only to the concerned HoD on his official email-id by 3thSeptember 2020 with the subject line “Application Form for Admission inSemester”.
- After verification of application form, and the Income Certificate(if applicable), concerned HoD will allow the student for payment through MIS.
- The students of the NIT Scheme (5, 7, and 9th Semesters) should use the Institute payment gateway at:- <https://results.nitrr.ac.in/opp/>. The link for fee payment by 3rd semester CBCS scheme students (UG & PG) will be announced later.
- Please note that the last date of payment of fee is 13th September2020. There after late fee will be applicable as follows :-

From 14th to 18thSeptember2020 at the rate of Rs.100/- per working day .
- Special Note: The Income Certificate must be issued by the competent authority (e.g DM/DC/Tahsildar/not below the rank of Tahsildar)on or after 01/04/2020 for the financial year 2019-20.Without annual income certificate, student will not be given remission of tuition fee.
- The students not desirous of taking admission due to COVID -19 must produce an option/undertaking given in the Annexure -II to the Head of their department by 18th September 2020 on the official email-id of the department failing which their withdrawal will not be considered.
- Those who are allotted to the new branch due to the branch sliding, should be sent their application to the HOD of new allotted branch.(applicable for B.Tech-III semester only)
